#### Operation Lone Star specific questions

23. We have two trial-level panels: a misdemeanor panel and a felony panel.

The misdemeanor panel mostly involves representing noncitizens charged with criminal trespass. Court proceedings are usually online. We currently appoint to cases charged in Maverick, Kinney, Webb, Jim Hogg, and Zapata counties. Travel to the border is typically no more than once every few months (though that is subject to change). Attorneys are expected to attend all in-person court hearings.

The felony panel mostly involves representing U.S. citizens charged with human smuggling. While some proceedings are online, most are in person. We appoint to cases charged in Maverick, Kinney, Val Verde, Jim Hogg, and Zavala counties. Travel to the border occurs at least once per month (though that is subject to change). Attorneys are expected to attend all in-person court hearings.

We compensate attorneys for their travel time.

- 29. Lawyers on our panel are assigned cases once every four weeks. We expect our lawyers to visit their clients within three business days of the appointment. These visits can take place via Zoom. Would you have any issue meeting this expectation?
- 30. We provide the lawyers on our panel access to a significant amount of resources, including access to LSDO staff that can help support your efforts. This frequently results in collaboration between the staff and the lawyer. Lawyers on the panel also often collaborate with each other. Do you have any experience working in that sort of environment? Do you like working in that sort of environment?

31. Operation Lone Star cases often present novel, complex, and interesting legal issues. Have you had experience litigating those sorts of issues? Submission of a copy of a motion, writ, or brief authored by you with this application is encouraged.
